**Camp Philosophy** The Greater Experience Soccer Academy Summer Camp provides a unique experience, primarily focused on goal scoring, for field players AND goalkeepers to train separately AND refine their skills against each other. Each day, goalkeepers and field players participate separately in intensive training focusing on finishing and shot handling, practice those skills facing each other in integrated training and small-sided games, and test themselves in realistic team game situations. In this way, each player is appropriately prepared and challenged to succeed in the most critical part of the soccer field.

Enrollment is open to girls and boys, goalkeepers and field players, from age 4 to 17. Campers are grouped by age and skill level.

**Location/Facilities** St. Timothy’s School in Baltimore County is a private girls’ boarding school for grades 9 through 12. Camp facilities include:

- A modern, first-class DORMITORY, with comfortable rooms for two or three, full bathrooms, and a large common lounge area (girls and boys will be housed on different floors, among the staff counselors)
- A fully-equipped, top-notch DINING HALL, providing three full, nutritious, delicious meals each day
- Two full well-manicured SOCCER FIELDS, in top match condition
- An OUTDOOR POOL for daily water activities, under the supervision of a certified lifeguard
- A state-of-the-art GYMNASIUM for inclement weather and evening activities
